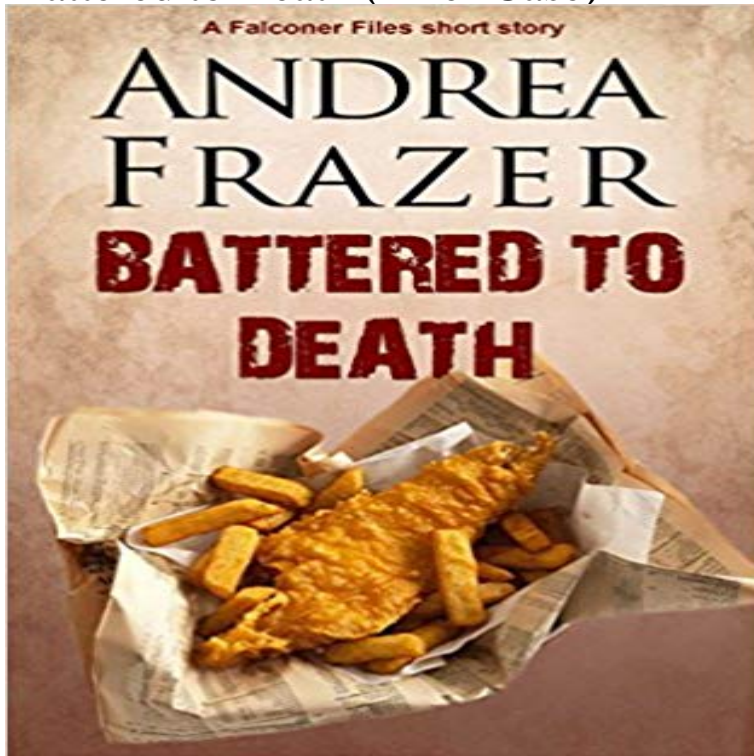


Battered to Death (Brief Case)
