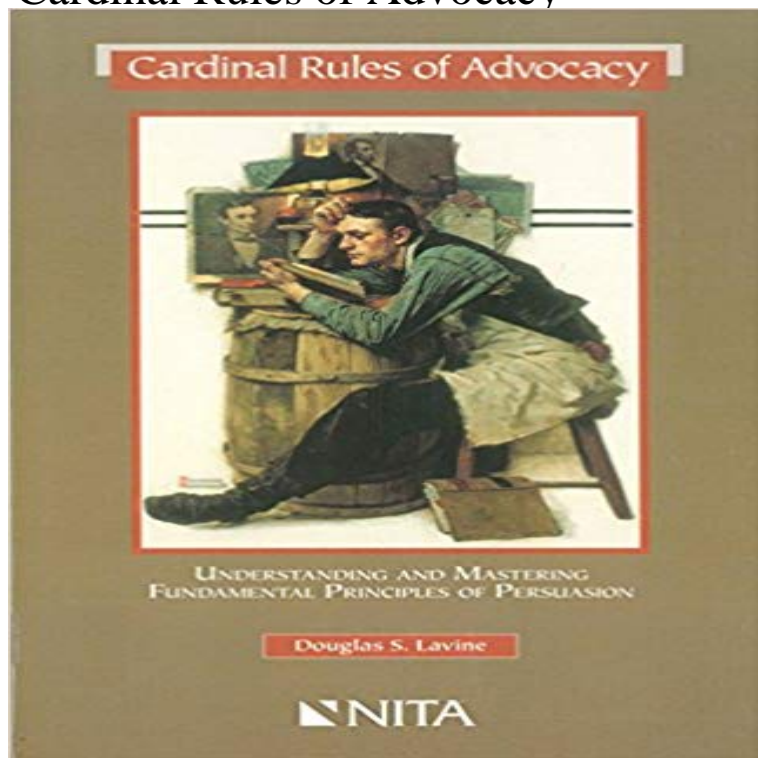


## Cardinal Rules of Advocacy
