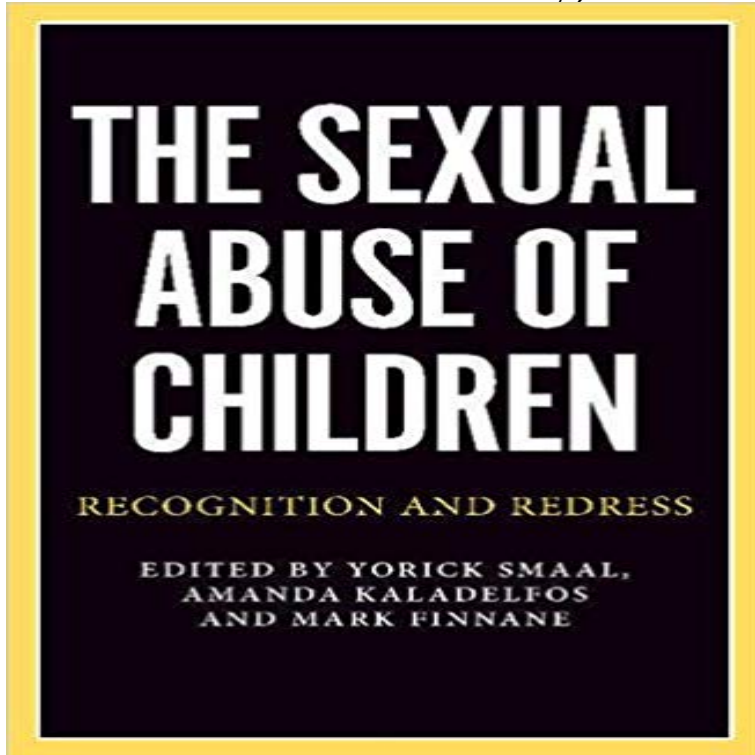


## The Sexual Abuse of Children: Recognition and Redress (Monash Studies in Australian Society)
